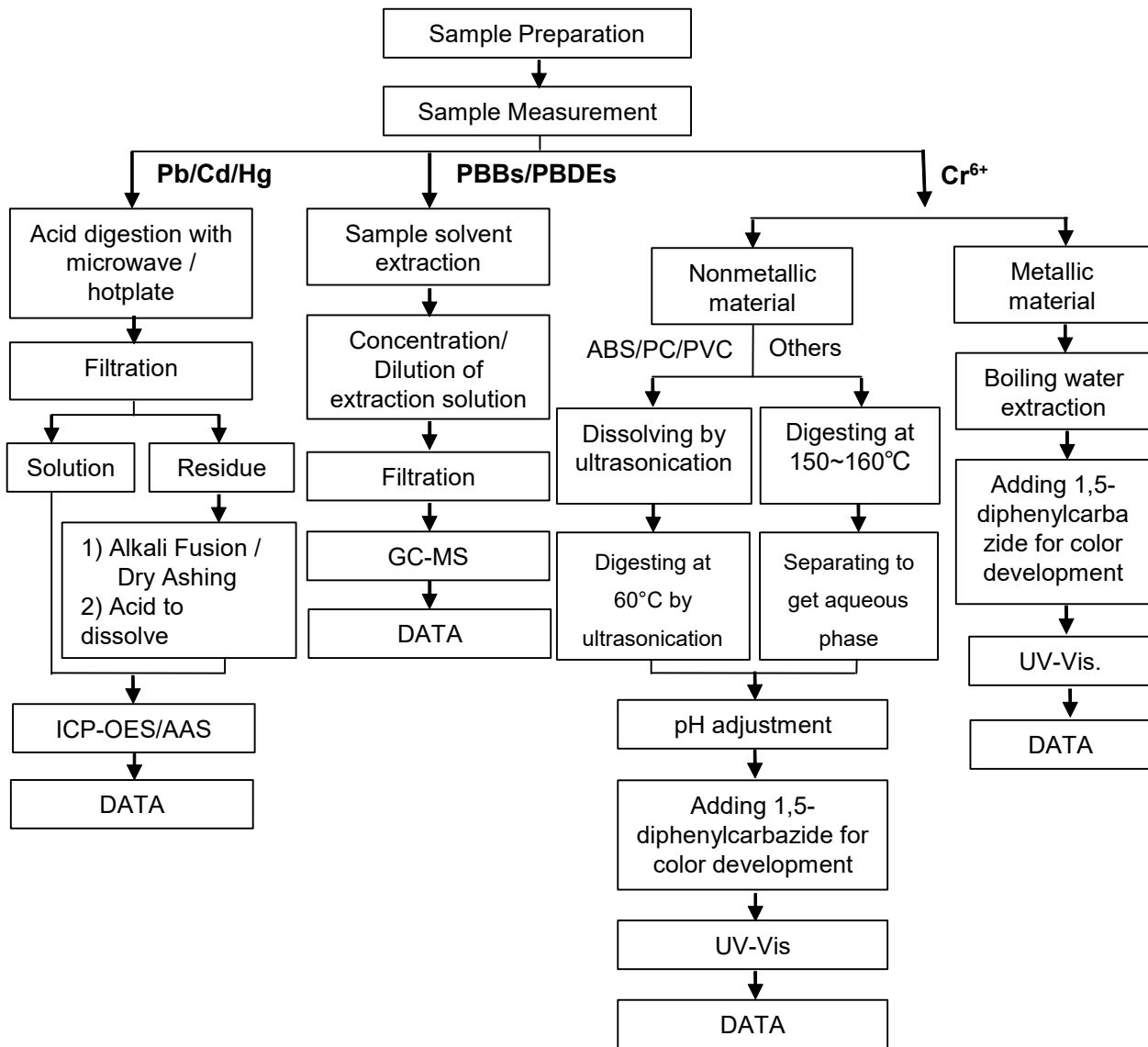

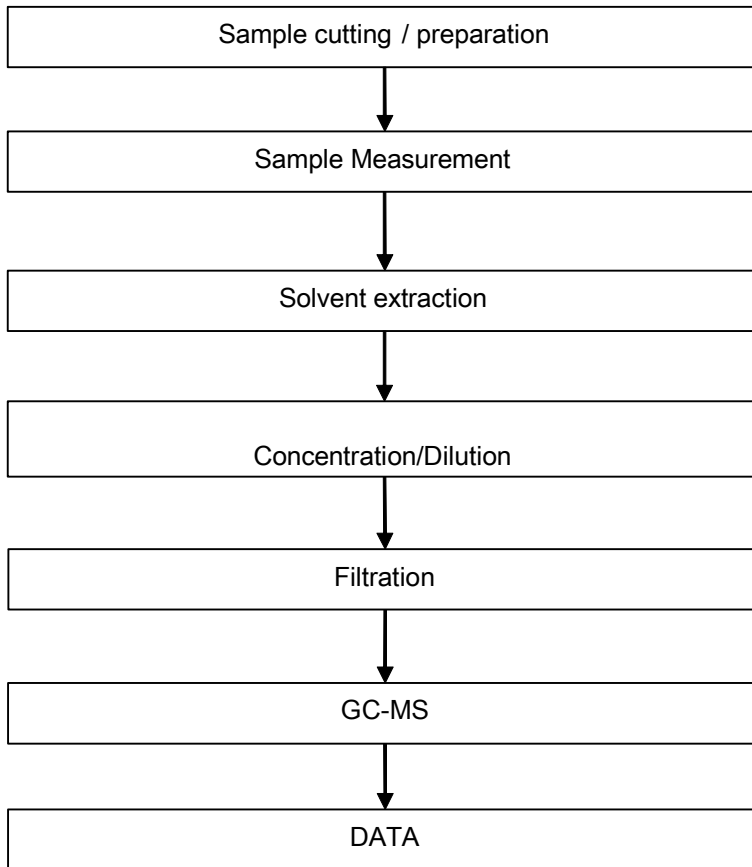

### Phthalates Testing Flow Chart

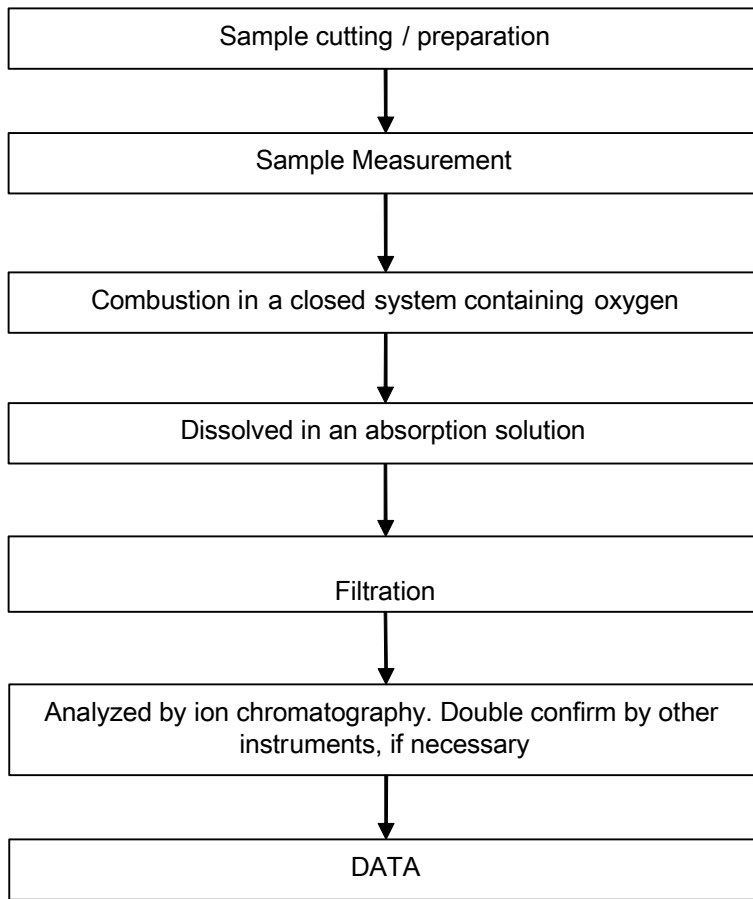

Halogen Testing Flow Chart

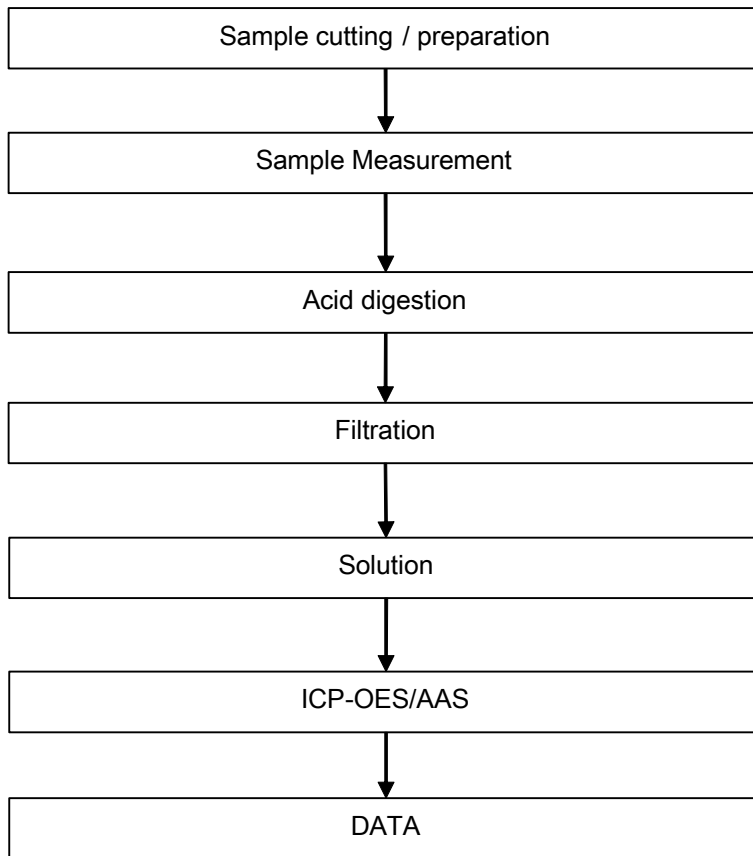

### Elementary Testing Flow Chart

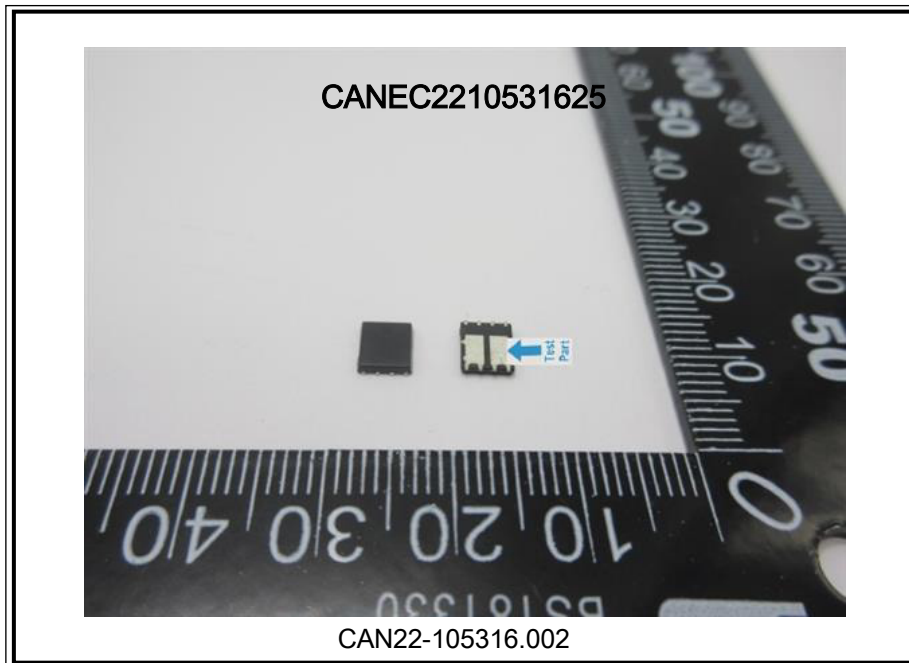
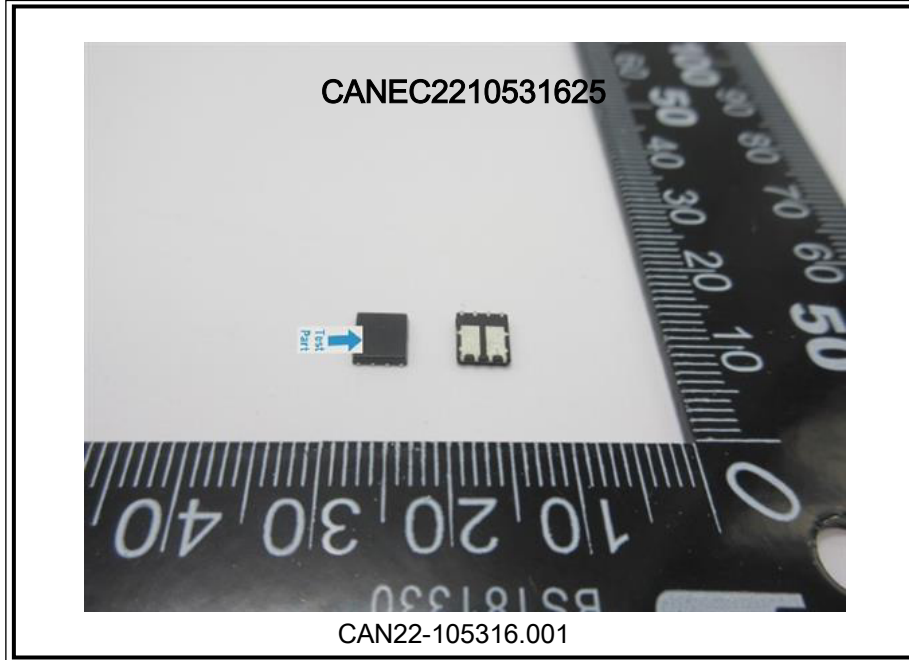
