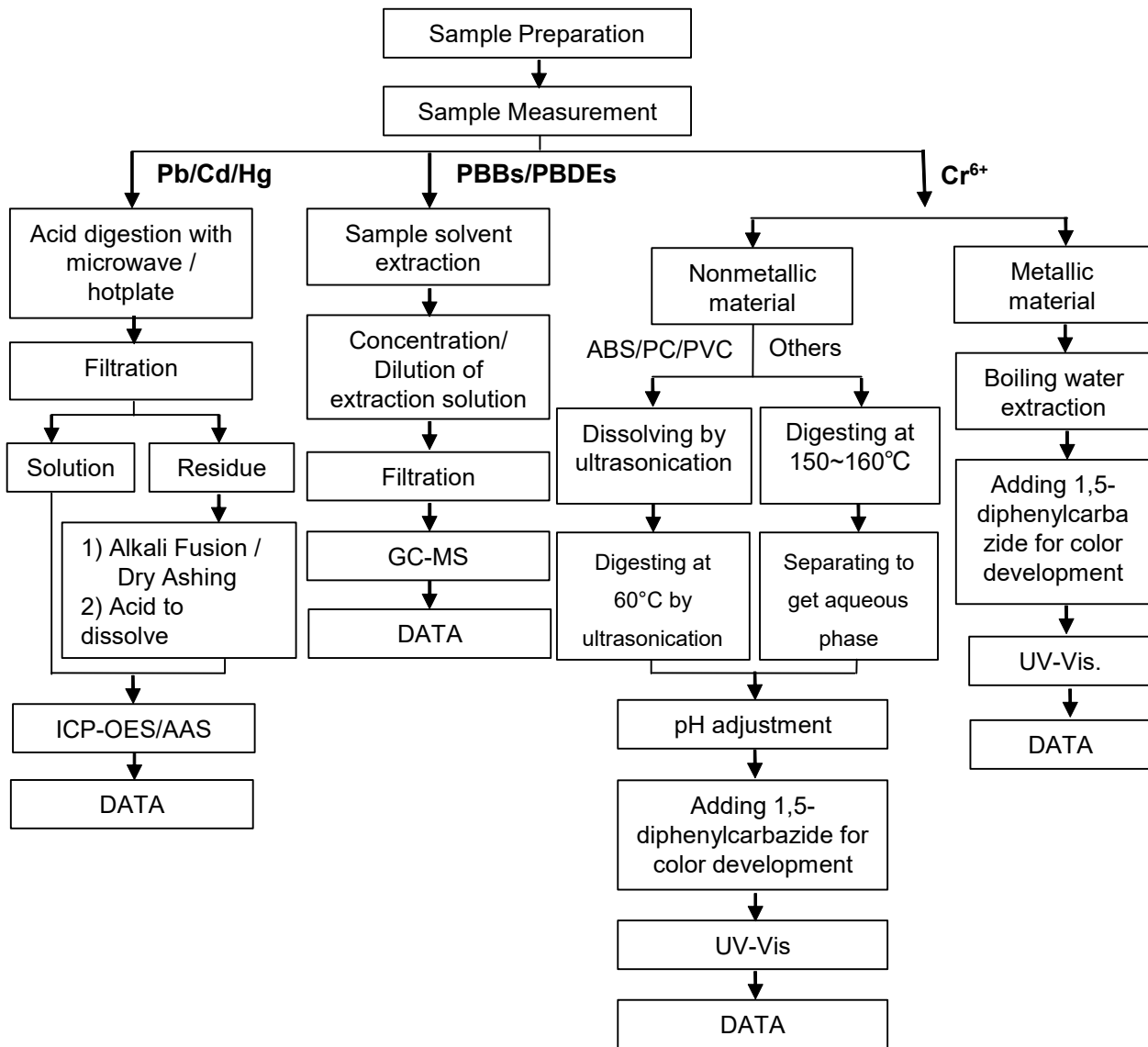

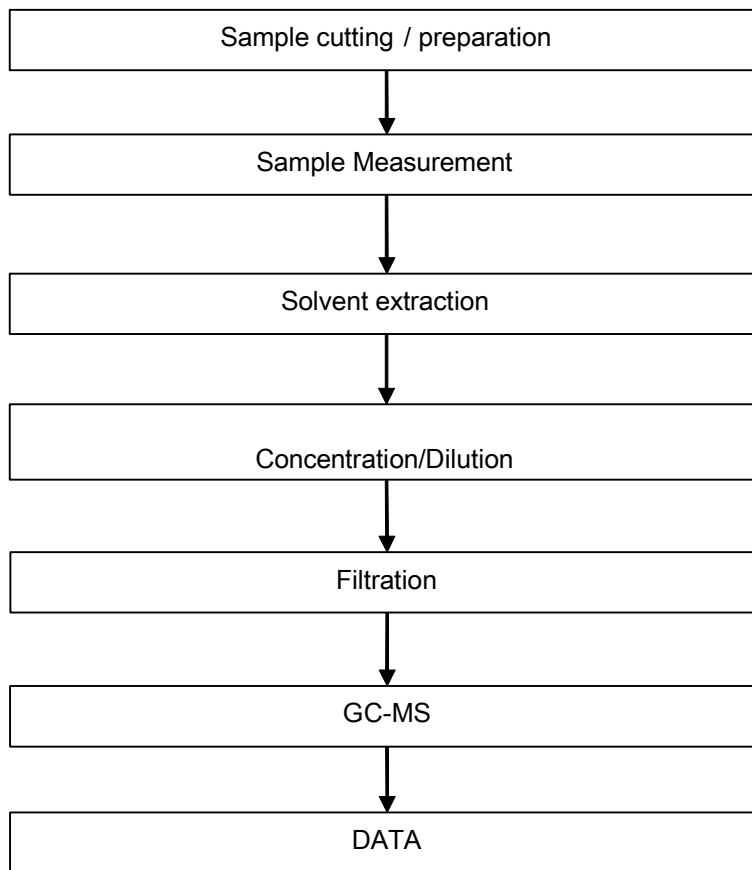

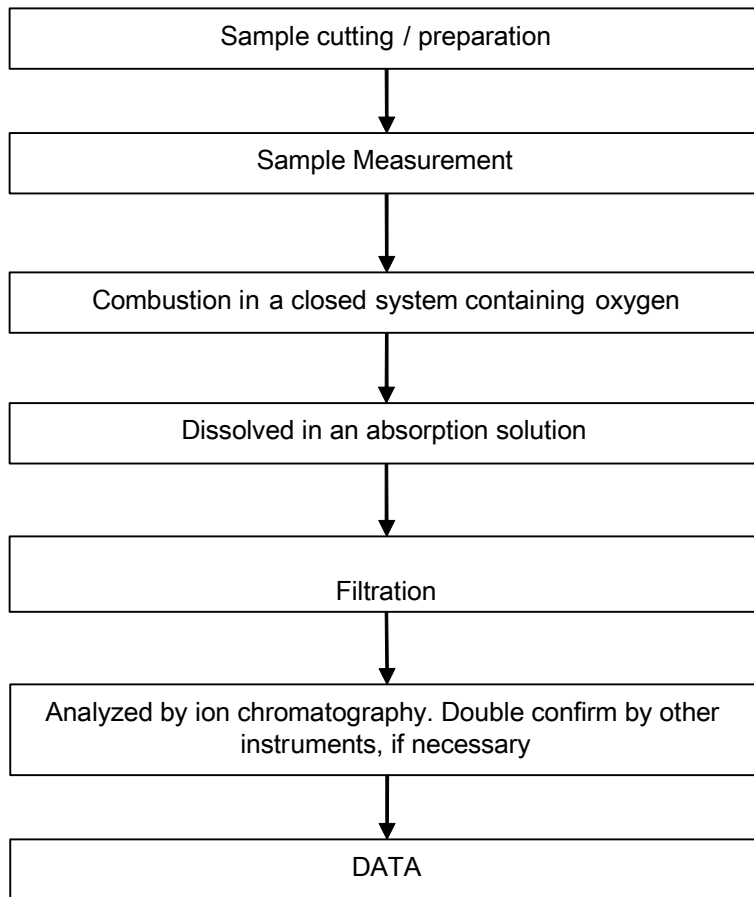

Halogen Testing Flow Chart

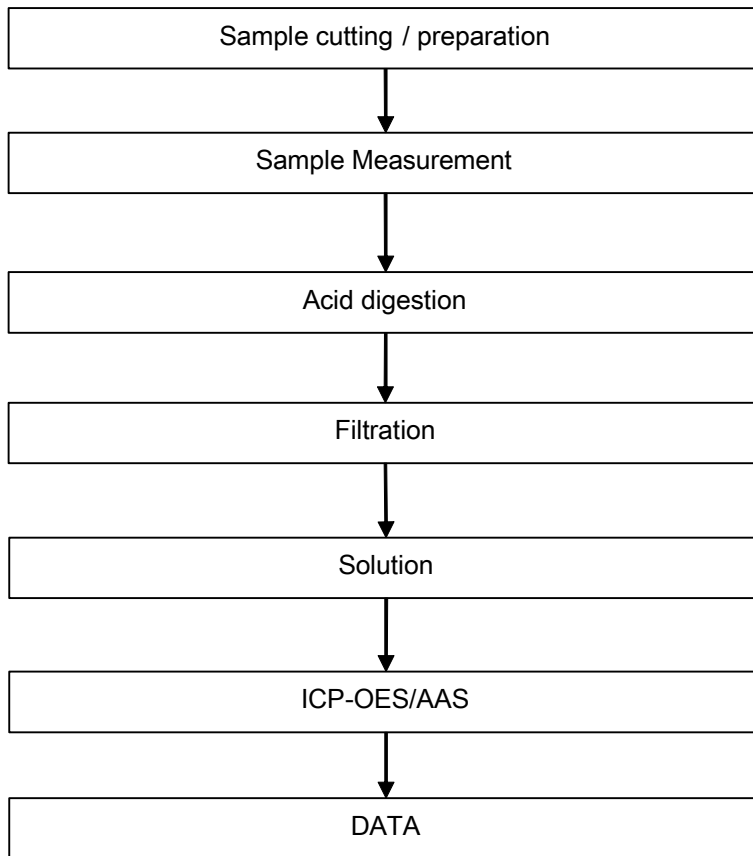

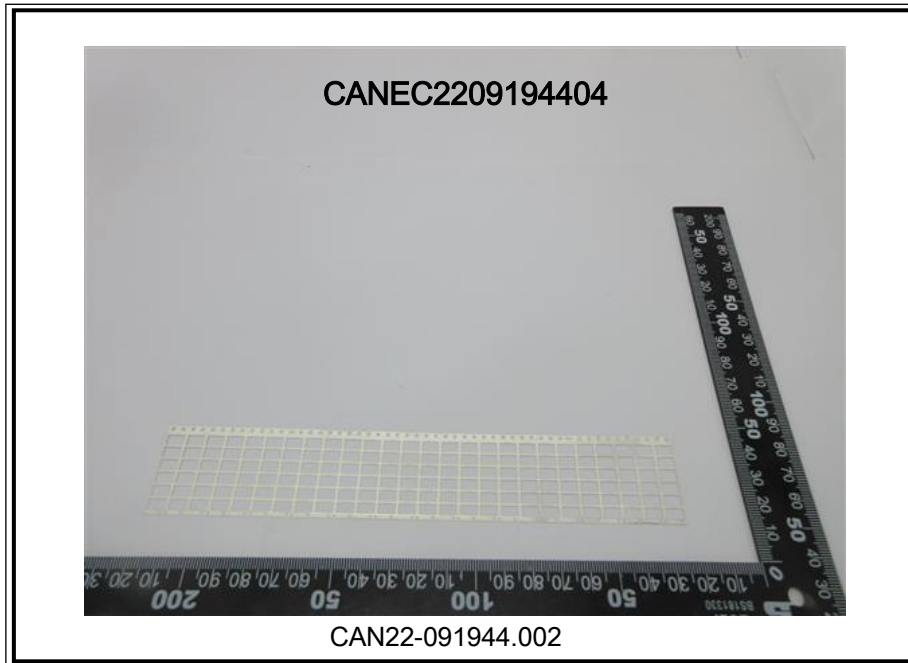
