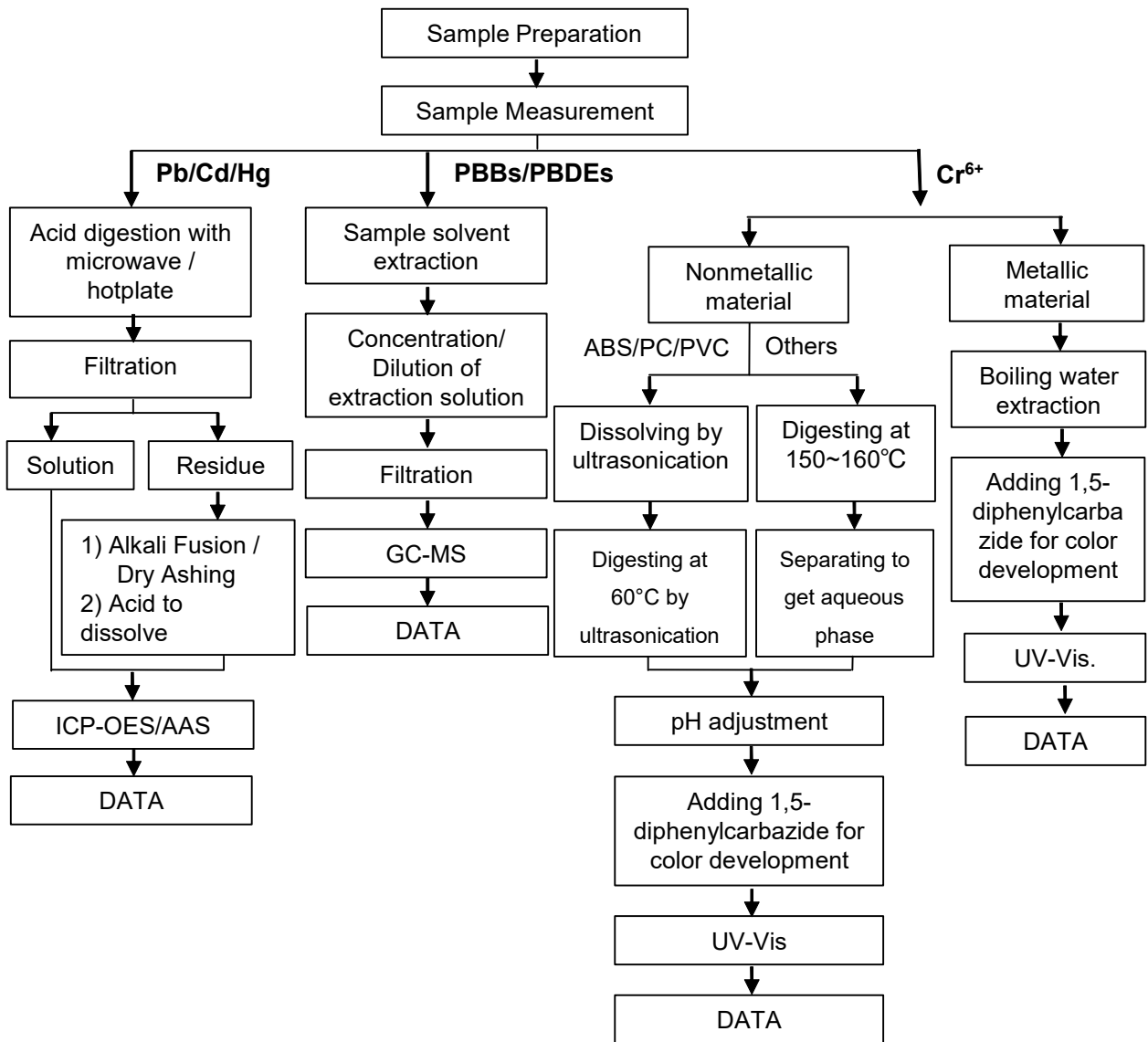

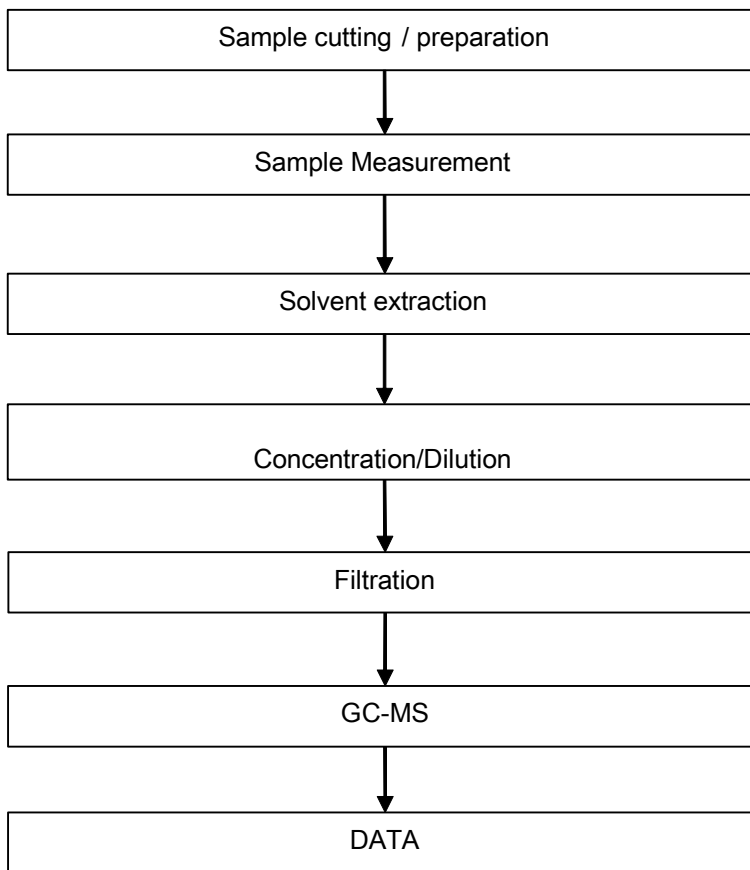

Phthalates Testing Flow Chart

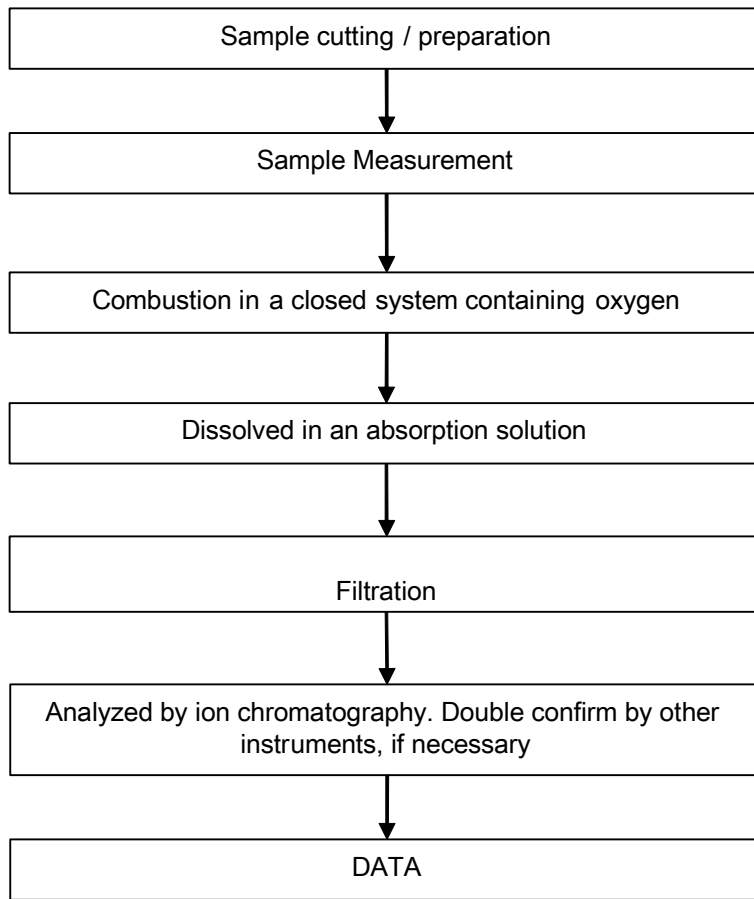

Halogen Testing Flow Chart

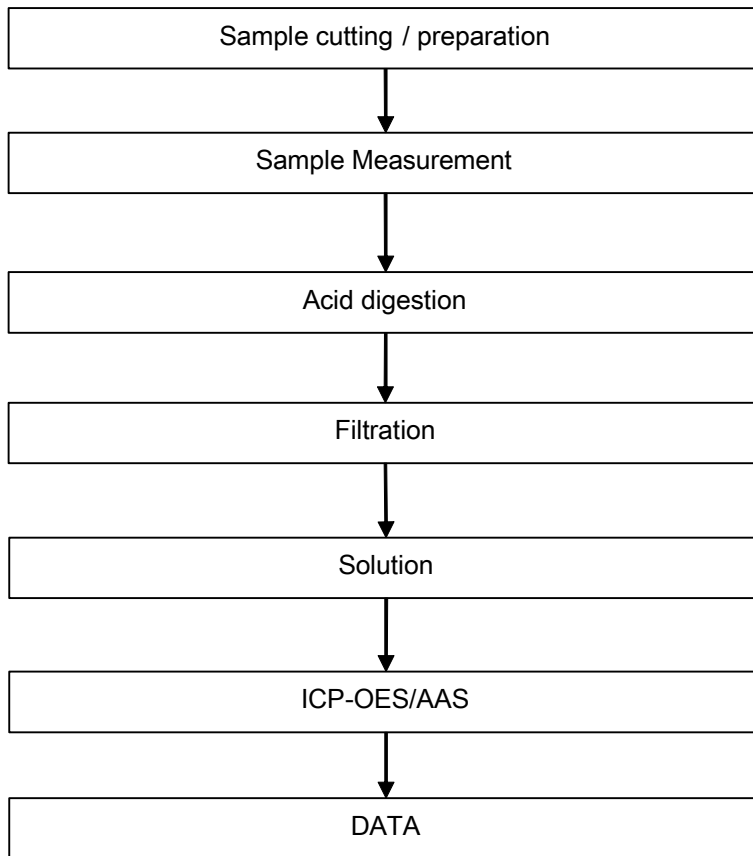

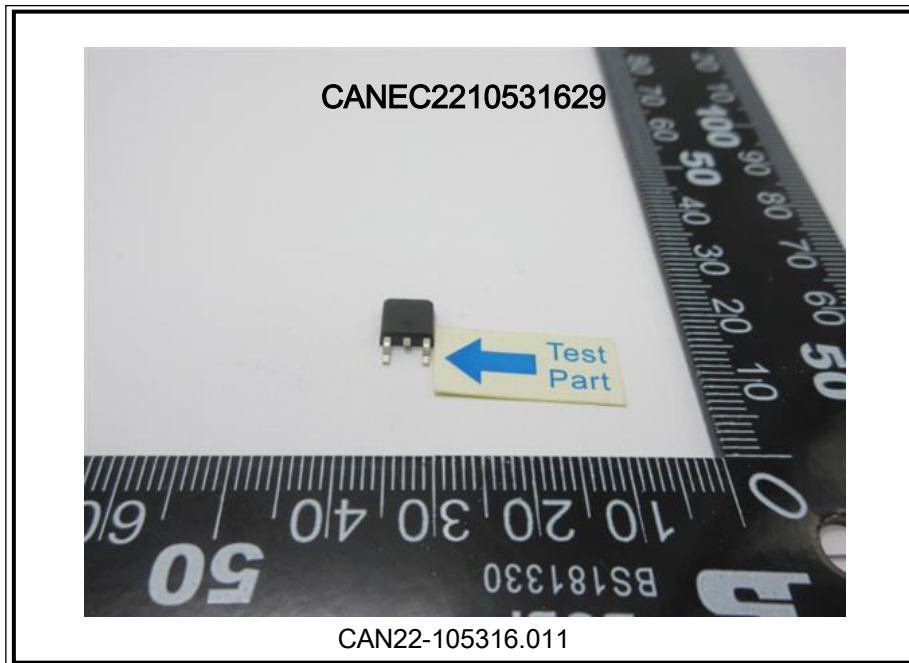
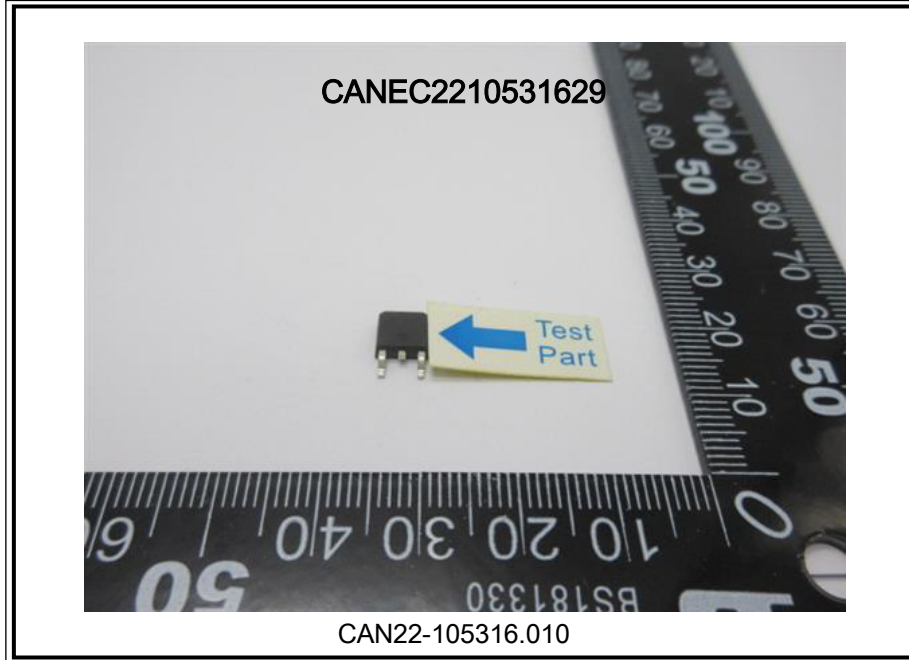
Elementary Testing Flow Chart

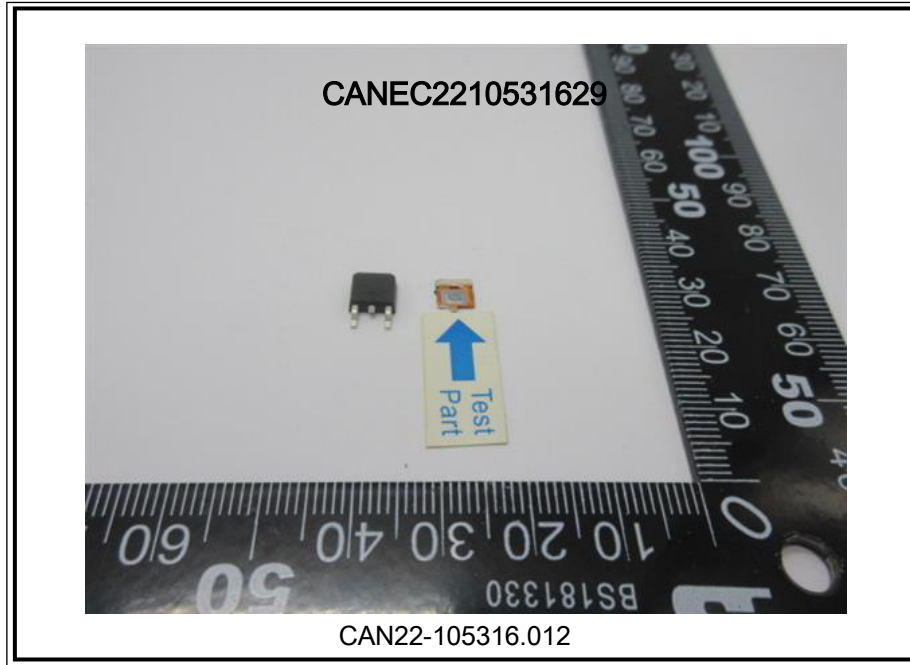
